In response to [FauxCapitalist's Joel Skousen's critique of World Bank whistleblower Karen Hudes](#), dated April 5, 2014, Project Humanbeingsfirst.org submitted the following [comment](#) on May 21, 2015

Hello.

Any time I hear the word "whistleblower" my mind says it's a tune played by the Mighty Wurlitzer (of which I have written about here: <http://tinyurl.com/MightyWurlitzer>).

Why do I think so? Firstly, because the hard reality of statecraft is not of idiocy of the *Übermensch*, but of brilliant political science and state-secret silence: **those who know do not speak; those who speak do not know; those who know and speak always sleep with the fishes.** For a State, especially when it is a superpower state, and more especially when it is run as an oligarchy from behind the scene, as was noted by its long dead director of counter-intelligence, James Jesus Angleton, "**Deception is a state of mind and the mind of the State.**"

Therefore, whistleblowing, unless PROVED otherwise, is only a tune played by the Mighty Wurlitzer. The burden of proof is with the whistleblower. The burden of skepticism is upon everyone else. Here I carry my share of that burden. And evidently, Mr. Joel Skousen has done the same. As has evidently the author of fauxcapitalism, Mr. Jason Erb (if that is a real name and not another nom de plume). Based on my quick perusal of the comments, some of the commenters are also not remiss in their due diligence.

Since the proof of the pudding is in its eating, as the saying goes, I subsequently look for a few things before I can be convinced of anything or anyone in this realm of statecraft, especially when one has no first hand domain or fact knowledge of what is being revealed.

- 1) sleeps with the fishes?
- 2) puts the toad in the punch bowl, or poisons her own well?
- 3) keeps the core axioms and presuppositions of the big lies, or of power, intact?
- 4) reveals something that is really new, or is really a state secret of any significant value, or is still current in its import and not already a *fait accompli*, and still does not sleep with the fishes, and does not poison her own well, and does not retain the core presuppositions as axioms?

In this case of Ms. Karen Hudes, she immediately struck me as a mind control candidate sent to create confusion among the idiotic dissent cadre as either a *useful idiot*, or *Manchurian candidate* who is an outright agent of deception. Which one of the two is hard to tell. But it also does not matter as the result is the same whether she is a witting agent or an unwitting useful idiot.

She is deception personified because of items 1) and 2) on the one hand, and item 4) on the other. She does not sleep with the fishes, she poisons her own well with outlandish statements, and she revealed nothing really shocking or of great significance. The 180 billion dollars in bond issue not being properly accounted in their books, true or not, pales in comparison to the tag-team raping of developing nations by the WB-IMF which has put these nations of the world in some 57 trillion dollars in debt. That number comes from John Perkins in *A Game as old as Empire*, pg. xx. And whether that number of 57 trillion is itself correct, the empirical fact that all developing nations are beholden to the WB-IMF in enormous debt burden which takes away from their domestic social spending creating enormous deprivation even when these nations have natural riches under their soil which is subsequently privatized in lieu of more loans for debt-servicing, is itself an empirical truth visible for all to see. The 180 billion issue raised is noise, a low order bit, and quite insignificant in the scheme of things. The world already understands how Bretton Woods has screwed the developing nations with unpayable debt just like some in the developed nations have now come to understand how private central banks coining their money as public debt has screwed them under unpayable

national debt in the trillions. To use a metaphor, Ms. Karen Hudes has come to town shouting *the Russians are coming the Russians are coming* when all the barbers in town already know it. The fact that she is still living, and may she live long and prosper, and conveniently discredited her own self with her [outlandish tales of pointy headed species wearing the Jesuit uniform](#) running the world, is a text book template that is continually repeated.

Please permit me to reproduce below a letter I wrote to Mr. David Icke some years ago and it exactly captures this template of Ms. Karen Hudes. This is why, the skepticism betrayed by Mr. Joel Skousen is more than justified. And the most important point raised by Mr. Skousen is that there is no way Ms. Karen Hudes can know first hand many of the things she asserts, as these are above her pay grade. The fact that Ms. Karen Hudes provides no documentary evidence which can be examined, makes her akin to the tens of so called "whistleblowers" that Project Camelot loves to interview for which its interviewer Ms. Kerry Cassidy has acquired almost a fanatic following of useful idiots (explained in my detailed report on the outlandish UFO crap: <http://tinyurl.com/Alien-UFO-Agenda> ; and in my letter to Ms. Kerry Cassidy <http://tinyurl.com/agents-of-deception>). Zahir's Response, July 22, 2016:

I must either be really really dunce or missing something really really profound here --- The Board of Governors of the World Bank and IMF, among the most pernicious and insidious legal instruments of usurping national sovereignty of developing nations through their lending-debt-restructuring-public-taxation-traps that force debtor nations to sell off their national assets and their public commons for a song under the neoliberal globalization one-world agenda of the financial oligarchy designed to legally steal the world's assets and put these under interlocking networks of corporate board ownerships and board controls, appoints Karen Hudes to oversee that the Network of Global Corporate Control does not steal the world's remaining assets?
